INFORMATION REGARDING COMPULSORY SCHOOL FEES 2023

The following arrangements, concerning the payment of compulsory school fees for 2023, were set up by the Governing Body and approved by parents at the Budget meeting held on **10 November 2022**.

THERE WILL BE A 4% INCREASE IN SCHOOL FEES FOR 2023

1. Both the father and mother and/or, where applicable, the guardian(s) of every pupil are jointly and separately responsible for school fees in respect of such a pupil. You, in your capacity as parent/guardian, are liable in terms of Section 40 of the South African Schools Act, for the payment of tuition fees which is legally enforceable.
2. Payments must be made by the due date. School fees are payable in full, in advance at the start of the academic year. Should payment of 10 equal monthly instalments be arranged, each such payment must be made **by no later than the 7th day of each month** from January to October. The parent/guardian is responsible to ensure timeous payment by means of the method chosen, i.e. by debit order, cheque or electronic transfer.
3. **If any payments are late or not received as undertaken, the full outstanding balance of school fees for the year, as at the date of non-payment, will become due and payable immediately.** If the full balance due is not immediately settled, Labiance Primary School will hand such amounts over for collection.
4. Should it be necessary for the school to instruct its attorneys or any collecting agent to collect school fees, the parent/guardian concerned, will be responsible for all collection costs, including legal fees at the attorney and client scale plus collection commission.
5. We inform you timeously of the school fees so that you can make provision in your budget for 2023. **No payments will be allowed to be made at the end of the year (i.e. waiting for November bonus).** No school can be properly managed if the money is only received during the last months of the year. Payments are thus made by paying before the end of February by means of debit-order/internet banking over a period of ten months.
6. Full, or partial exemption from school fees, according to the Norms and Standards, are available to parents. **Please note that you have to re-apply for these exemptions in 2023.** Parents may request the necessary forms for full/partial exemptions from the finance office at school.

The annual school fees for Gr 1-7 for 2023 = R 9 460 ÷ 10 = R 946 per month.
 The annual school fees for Gr R for 2023 = R 11 500 ÷ 10 = R 1 150 per month

Grade R is not compulsory education: Therefore, application for Exemption of School Fees does not apply.
